

#### ACADEMIC AND PROGRAM AFFAIRS ANNUAL REPORT

## AY 2020-2021

The Academic and Program Affairs Committee had a very productive and meaningful academic year in 20-21, and we continue to do the same in 21-22.

Part of the work of the committee involves continually helping to maintain the highest quality and most timely new courses. We approved modification to sixteen programs in the 2021-22 academic year. Our work here well represents the ways the School for International Training can quickly respond to massive change without forgoing our mission, all while maintaining an eye to the future. For instance, we modified many programs from immersive, in-country learning experiences to hybrid experiences that allowed for online content. In addition, we coordinated some minor maintenance on other programs, codifying what our program staff and faculty have learned in the process of running the program. We are particularly proud of the work we are doing with Brattleboro Union High School; with our cooperation students in a relatively rural area can enjoy a world-class, global education component.

Our new programs reflect the reality of living in the Covid era. We developed several summer programs as well as some online options for virtual work. While this was prompted by the need to supplement our portfolio in light of the global pandemic, what we have achieved is much more substantial. We are now able to offer shorter, more affordable alternatives for students whose circumstances are not conducive to entire semesters abroad. These more accessible programs also reflect our core social justice values. Programs on climate change, food security, development, and human trafficking speak directly to the most pressing issues engaging humanity right now. Likewise, the new summer Arts Studio in Prague helps us foster optimistic creative responses to the universal human condition.
